**Temporary Restraining Order, Including a Temporary Injunction, A
Temporary Asset Restraint, Expedited Discovery, and Order to Show Cause**

THIS CAUSE is before the Court on Plaintiff's *Ex Parte* Motion for Temporary Restraining Order, Including a Temporary Injunction, A Temporary Asset Restraint, Expedited Discovery, and Order to Show Cause (the "Motion"), [Doc. 3], against the defendants identified in the Amended Complaint ("Defendants") and using at least the online marketplace accounts identified in Exhibit A hereto ("Defendant Online Stores"). The Court has reviewed Plaintiff's Motion and accompanying exhibits and concludes that Plaintiffs has satisfied the requirements for the issuance of an *ex parte* temporary restraining order (TRO) and the additional relief requested.

Plaintiff asserts that Defendants reach out to do business with United States residents by operating one or more commercial, interactive Defendant Online Stores

through which United States residents can purchase products using counterfeit versions of the Crystal3 Trademark:

Issuing this order without notice pursuant to Rule 65(b)(1) of the Federal Rules of Civil Procedure is appropriate because Plaintiff has presented specific facts in the Declaration of Yirong Zhou and accompanying evidence showing that Plaintiff will suffer immediate and irreparable injury, loss, or damage before Defendants can be heard in opposition. Specifically, Plaintiff shows that in the absence of an *ex parte* order, Defendants could and likely would modify registration data and content and move any assets from accounts in U.S.-based financial institutions, including Amazon Pay accounts, to offshore accounts.

Accordingly, this Court **ORDERS** that:

1. Defendants, their affiliates, officers, agents, servants, employees, attorneys, confederates, and all persons acting for, with, by, through, under, or in active concert with them be temporarily enjoined and restrained from:

- a. using the Crystal3 trademark or any reproductions, counterfeit copies or colorable imitations thereof in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not a genuine Crystal3 product or not authorized by Plaintiff to be sold in connection with the Crystal3 Trademark;
 - b. passing off any product as a genuine Crystal3 product that is not Plaintiff's or not produced under the authorization, control or supervision of Plaintiff and approved by Plaintiff for sale under the Crystal3 Trademark; and
 - c. manufacturing, shipping, delivering, holding for sale, transferring or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for Plaintiff, nor authorized by Plaintiff to be sold or offered for sale, and which bear the Crystal3 Trademark, or any reproductions, counterfeit copies, or colorable imitations thereof.
2. Any third party with actual notice of this order who is providing services for any Defendant, or in connection with any of Defendant Online Stores, including, without limitation, any online marketplace platforms such as Amazon, eBay, web hosts, sponsored search engine or ad-word providers, credit cards, banks, merchant account providers, third party processors and

other payment processing service providers such as PayPal and Amazon Payments, and Internet search engines such as Google, Bing and Yahoo (collectively, “Third-Party Providers”), shall, within five business days after receipt of such notice, provide to Plaintiff documents and records with the following information, to the extent such information in such the person’s or entity’s possession or control:

- a. the identities and locations of Defendants, their agents, servants, employees, confederates, attorneys, and any persons acting in concert or participation with them, including all known contact information, including any and all associated e-mail addresses;
- b. the nature of Defendants’ operations, identifying information associated with the Defendant Online Stores and Defendants’ financial accounts and a full accounting of Defendants’ sales and listing history related to their respective Defendant Online Stores; and
- c. any financial accounts owned or controlled by Defendants, including their agents, servants, employees, confederates, attorneys, and any persons acting in concert or participation with them, including such accounts residing with or under the control of any banks, savings and loan associations, payment processors or other financial institutions, including, without limitation, PayPal and Amazon Pay, or other

merchant account providers, payment providers, third party processors, and credit card associations (*e.g.*, MasterCard and VISA).

3. Plaintiff may serve expedited written discovery on Defendants, pursuant to Federal Rules of Civil Procedure 33, 34 and 36, related to:
 - a. the identities and locations of Defendants, their officers, directors, employees, agents, subsidiaries, distributors, and all persons in active concert or participation with any Defendant, including all known contact information, including any and all associated e-mail addresses; and
 - b. the nature of Defendants' operations, methods of payment for services, identifying information associated with the Defendant Internet Stores and Defendants' financial accounts and a full accounting of Defendants' sales and listing history related to their respective Defendant Internet Stores.
 - c. Defendants shall respond to any such discovery requests within seven days of service.
4. Upon Plaintiff's request, the Third-Party Providers as defined in Paragraph 2, shall within five business days after receipt of such notice disable and cease providing services being used by Defendants to engage in the sale of goods using the Crystal3 Trademark including the ASINs identified in **Exhibit A**.

5. Defendants and any persons in active concert or participation with them who have actual notice of this order shall be temporarily restrained and enjoined from transferring or disposing of any money earned by each Defendant from its sales of any of the ASINs identified in **Exhibit A** (“Accused Revenue”) until further ordered by this Court.
6. PayPal, Inc. (“PayPal”), Amazon Payments, Inc., and any banks, savings and loan associations, payment processors, or other financial institutions shall, within two business days of receipt of this order, for any Defendant or any of the Defendant Online Stores:
 - a. locate all accounts and funds connected to Defendants or the Defendant Online Stores, including, but not limited to, any PayPal or Amazon Payment accounts connected to any e-mail addresses provided for Defendants by third parties; and
 - b. restrain and enjoin, up to the amount of Accused Revenue, any such accounts or funds from being transferred or disposed of until further ordered by this Court.
7. Pursuant to this Court’s discretion, Plaintiff shall not presently be required to post a bond or other security. BellSouth Telecommunications, Inc. v. MCIMetro Access Transmission Servs., LLC, 425 F.3d 964, 971 (11th Cir. 2005). However, any Defendant may appear and immediately challenge this

portion of the order by providing the Court with a reasonable estimation of its potential lost sales, along with supporting documentation sufficient to allow the Court to decide what an appropriate amount of surety would be. Plaintiff will then have one week in which to file a response.

8. After receiving confirmation that Defendants' funds have been restrained, Plaintiff **SHALL** immediately serve each Defendant with copies of the Amended Complaint, TRO Motion, and this order using the email addresses provided by Defendants directly or by the Third-Party Providers and **SHALL** file the proof of service on the docket within 24 hours of service.
9. Any response or opposition to Plaintiff's motion for preliminary injunction must be served on Plaintiff's counsel by August 31, 2026, and, along with proof of service contemporaneously filed with the Court. Plaintiff shall file any reply memorandum, along with proof of service, no later than September 7, 2026. These dates may be revised with the Court's approval.
9. The Parties shall appear for a hearing on September 8, 2026 at 2:00 PM in Courtroom 1708, United States Courthouse, 75 Ted Turner Drive, S.W., Atlanta, GA, 30303, at which time Defendants and any other affected persons may challenge the appropriateness of this order and move to dissolve the same, and at which time the Court shall hear argument on Plaintiff's requested

preliminary injunction. Defendants shall appear and show cause why said preliminary injunction should not issue.

The Court **CAUTIONS** Defendants that failure to appear at the hearing may result in the imposition of a preliminary injunction against them pursuant to 15 U.S.C. § 1116(d), Rule 65 of the Federal Rules of Civil Procedure, 28 U.S.C. § 1651(a), and the Court's inherent authority.

This TRO shall expire **14 DAYS** after it is entered unless before that time the Court, for good cause, extends it for a like period or Defendants consent to a longer extension.

Accordingly, for the foregoing reasons, the Court **GRANTS IN PART** Plaintiff's Motion for TRO [Doc. 3] and **RESERVES** its ruling as to Plaintiff's request for preliminary injunction pending the September 8, 2026 hearing.
